It's a form of abuse to me. . .It's like the talent or the spirit or the motivation or the passion that you are abusing, maybe killing some of that spirit that you might have within him or her." (R) 	<p>Participants described a wide variety of potential, intentional harms and abuses. The most commonly discussed abuses in public discourse, physical and sexual abuse, were considered less common than psychological abuse and intentional material deprivation. The variety of harms described demonstrate that athletes' perspectives on abuse can be nuanced. Though many abuses were listed as harmful it was not always clear to athletes whether some level of harm must exist within sports.</p>

"Athletes prepare themselves to go for competition, but an administrative officer...and his own friends or colleagues take the money...and process everything. At the end of the day, they'll say the government have no money [to bring you to the competition]."	Ghana

"The athlete was victim of a competition, he didn't go to the competition because they didn't inform him about it."	Brazil
